

## PROMOTION

- Creating a web page
- Short presentation of PROGRESS on other web pages (NGO, Social protection institute of the Republic of Slovenia,....)
- Ordering brosures from European Commission in Slovenian language
- Creating the contact network
- Informing organizations about PROGRESS Calls for Proposals/Tenders of by email
- Organizing a conference about PROGRESS
- Preparing a promotion plan until 2013 (obtaining advise from external adviser)

## **CO-FINANCING**

Budget planning for 2008 in 2009
Two ways of co-financing:

prior to sending application to the EC after sending application to the EC

#### **CO-FINANCING**

#### **Prior to sending application to the EC**

- Organizations should send an aplication to the Ministry 17 days before sending it to EC
- Commissions select the projects for cooperation
- Approval by the Minister
- Letter of intention
- Approval of the project by the EC
- Contract betwen the organization and the Ministry
- Payment after realization of the activity (Claim for payment)

#### **CO-OFINANCING** After sending application to the EC

The Ministry recives a letter from organization for co-financing

- Approval of the co-financing amount
- Contract between the organization and the Ministry
- Payment after realization of the activity (Claim for payment)
